

Caroline Health Department Drowning Prevention Grand Prize Sweepstakes Official Rules

To enter this Sweepstakes, you must agree to and abide by these official rules (“Official Rules”).

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

ADMINISTRATOR: Caroline County Health Department, 403 S. 7th Street, Denton, Maryland 21629

ENTRY & ELIGIBILITY: Those who meet the criteria below will be entered into the Caroline County Health Drowning Prevention Grand Prize Sweepstakes (the “Sweepstakes”):

1. By participating in the Drowning Prevention Art Contest, each participating child and their legal guardian agree to be entered automatically into the Grand Prize Sweepstakes. Each child who submits a valid entry in the Art Contest will be entered into the Grand Prize Sweepstakes (“the Sweepstakes”).
 - a. Each child may receive one entry into the Sweepstakes for each month of the contest in which they submit a valid entry (for a maximum of five Sweepstakes entries per child).

 - c. All eligibility requirements detailed in the Art Contest rules carry over and apply to the Grand Prize Sweepstakes.
2. The Grand Prize will be issued to a legal guardian of the winning child. The legal guardian will be considered the “Sweepstakes Prize Winner” of the Sweepstakes.
3. By accepting the Grand Prize and becoming the Sweepstakes Prize Winner, the legal guardian agrees to use it for the benefit of the winning child. The Grand Prize may also be used to cover costs of family members and/or friends traveling with the winning child.
4. The Sweepstakes Prize Winner accepts sole responsibility to determine how the Grand Prize will be used and to make all plans and arrangements related to its redemption.

RANDOM DRAWING/SELECTION OF WINNER/ODDS: The winning child will be selected from among all eligible entries received in a random drawing conducted by the Administrator at its office in Denton, Maryland. The drawing will take place on or about September 3, 2026. The drawing will be conducted by Administrator whose decisions are final and binding on all matters related to the Sweepstakes.

Sweepstakes is available to those who meet the ELIGIBILITY CRITERIA. Odds of winning depend on the total number of eligible entries received during the Drowning Prevention Art Contest.

PRIZES/APPROXIMATE RETAIL VALUES:

ONE (1) SWEEPSTAKES PRIZE ("Sweepstakes Prize"): One Sweepstakes Prize Winner will receive a \$1,500 gift certificate for Sun Outdoors, which may be redeemed for eligible accommodations, merchandise, and/or food purchases at participating Sun Outdoors resorts.

It is the sole responsibility of the Sweepstakes Prize Winner to redeem the full value of the gift certificate prior to its expiration. Any unused funds will be forfeited by the Grand Prize Winner.

MISCELLANEOUS PROVISIONS

Sweepstakes Winner may be required to complete, sign and return within three (3) business days of date on notification a Liability Release and Indemnification and a Publicity Release where allowed by law, as well as other documents that Administrator may require (collectively, "Prize Claim Documents").

Failure to respond to the initial notification within three (3) business days after notification, or failure to return the completed and signed Prize Claim Documents within the indicated time period will result in disqualification, prize forfeiture and selection of an alternate potential Prize Winner from among all remaining eligible entries received (time permitting).

DISPUTES.
